#### 4. First-aid measures

Inhalation

# Specific hazards arising from the chemical

Vapors may form explosive mixtures with air. Vapors may travel considerable distance to a source of ignition and flash back. # 7. Handling and storage

#### Precautions for safe handling

# Conditions for safe storage, including any incompatibilities
